Please take time to read these terms and conditions carefully before participating in any STU Arts classes and workshops. It contains important information designed to safeguard the wellbeing of our students and to ensure that the good name of our organizations continues to be associated with high quality teaching and the enjoyment of dance.

## Fees and Cancellation

- Students may cancel and/or reschedule classes via the online "my booking" system.
- As our costs are fixed, fees remain payable in cases of absence. There is no reduction or refunds for sickness or holidays.
- Fees are non-refundable, but may be credited for future STU Arts Dance services.
- Any increase in fees will be notified one term ahead of the increase.

# Methods of Payment

## <u>Timetable</u>

STU Arts Dance and teaching artists reserves the right to alter the timetables and its teaching staff as appropriate at any time without prior notice. However, we will inform all participants of any changes as soon as possible.
